Order of Business & Introduction of Guest Speaker: Lee County Commissioner, Kevin Ruane



**Kevin Ruane** was elected to the Lee Board of County Commissioners after serving as the Mayor of Sanibel for more than a decade.

He had visited Sanibel for 20 years with his family before purchasing a home there in 2004. Hurricane Charley quickly turned Kevin's attention to becoming a public servant. He signed on as a member of the Hurricane Damage Assessment Team in Sanibel.

Kevin was appointed to the Sanibel City Council to serve an interim position in February 2007. In May 2007, he was elected for a seat on the City Council. He was re-elected in March 2009 and was appointed Mayor in March 2010.

Kevin has served as a voting delegate for the Florida League of Cities. In 2016, he was instrumental in forming the largest compact for water quality in the organization's history with more than 165 mayors participating. In 2020, he was awarded the Florida League of Cities E. Harris Drew Municipal Official Lifetime Award.

In 2014, Gov. Rick Scott appointed Kevin to the South Florida Ecosystem Restoration Task Force. He was re-appointed in 2019 by Gov. Ron DeSantis.

Kevin attended both undergraduate and graduate schools at Pace University with a concentration in accounting and taxation. He took over for his father at his family's CPA firm and his corporate career included various senior executive positions with a subsidiary of a Fortune 100 company.

Today, his company, Castleton Capital, provides financing to small businesses throughout the United States. It's a family affair: wife Doreen, daughter Shannon and

- Filled an opening on the Sanibel City Council for 60-days. At the time Sanibel had \$16M of revenue, \$100M in debt, \$400,000 in Reserves. When he left Sanibel for Lee County Commissioner in 2020, the debt was down to \$18M, Pension System was 100% restored and the Reserves were \$12M, taxes had been cut 27%
- Lee County has a current budget of \$2.4 Billion dollars
- Kevin's main priority is water quality, a promise he made when running for office
- Kevin determined that Law & Order needed upgraded
- A goal of keeping taxes down in Lee County
- Needed to accelerate infrastructure
- Serving as chair of the Long Term Recovery Task Force
- FEMA requirements have eight (8) branches: Building; Planning; Capacity; Economic Recovery; Natural Resources; Cultural Resources; Education; Work Force
- Soon after Hurricane Ian eleven (11) bridges were repaired or replaced, 442 stop lights repaired or replaced
- A need for revenue replacement on Ft Myers Beach and Sanibel due to Hurricane Ian
- \$100M beach renourishment
- Currently running for his sixth election
